4) The school is being run by a society registered under the Societies Registration Act, 1860 (Act No. 21 of 1960) or by a trust established under any law from time to time in force.

5) Renewal of registration of the society, if necessary, will be ensured.

6) The school is not being run for the personal benefit of any individual, group or groups of individuals or anyone else.

7) Accounts of the school audited and certified by a chartered accountant and proper statements of accounts prepared as per rules.

8) The school shall admit 25% of the total strength of the class in the first class to children belonging to the weaker sections and underprivileged groups of the neighborhood and shall provide free and compulsory education till its completion. If the school provides pre-primary education, the same conditions will apply.

9) For the children referred to in paragraph 7, the expenses shall be reimbursed to the school in accordance with proviso 2 of section 12 of the Act. The school will have to maintain a separate bank account to receive this reimbursement.

10) The school shall not charge any capitation fee and shall not subject the child or his parents or guardians to any retrenchment process.

11) The school shall not refuse admission to a child for the following reasons:-

a) No proof of age of a child

b) seeking admission by any child within the extended period or after the extended period; or

c) Religion, caste, race or place of birth or any of these.

12) The school shall ensure that:-

a) No enrolled child shall be held back in the class or expelled from the school before completion of elementary education in the school.

b) No child shall be subjected to corporal punishment or mental harassment

c) The child shall not be required to pass any board examination till the completion of elementary education.

(d) Every child who completes elementary education shall be awarded a certificate as per rule 21.

e) Children with disabilities/special needs will be facilitate as per the provisions of the Act.

f) According to sub-rule (1) of section 23 of the Act, only teachers fulfilling the minimum educational qualifications will be appointed.

g) Teachers shall not engage themselves in any private teaching activity.

13) The school shall adopt the curriculum based on the subjects prescribed by the appropriate authority.

14) The school shall comply with the conditions and standards specified under section 19 of the Act.

15) No non-affiliated classes will be conducted in the name of the school inside or outside the school premises.

16) The school building or other structure or grounds shall be used only for Education and skill development.


17) The school shall provide time to time necessary information to the Director-School Education or the District Education Officer and shall comply with the instructions issued by the State Government Local Authority to maintain the accreditation of the school or to remedy the deficiencies in the running of the school.
